Memo from the President:

In the future, if it is obvious that discussion on a motion will take more than a reasonable amount of time, a time limit will be set and if necessary, the matter will be referred to a committee for further evaluation. A committee report, consisting of a summation of the views expressed, will then be presented at a subsequent meeting and a vote will be taken without further discussion. Members wishing to say more about the subject (s) may present their views to the committee during the period preceding the following months meeting.

It was great to hear so many of our gang going after points in the CQ phone contest, however, there were more than a few Southern Californians doing the same. A few of them were heard to say "We are very serious about this contest". Now is the time to get ready for the CW part November 26 and 27. Good luck.

Over the last few months I personally have noticed that QSL Bureau service has improved vastly relative to that which we of the "first half" have been experiencing. Perhaps the situation is now under control and things will flow smoothly in the future. The following is in reply to a personal letter from Dave, W6WX to Otto Miller, K6ENX.

Ed.

Dear Dave,

Thank you very much for your letter and for your kind words concerning my efforts in connection with the QSL Bureau. I am, however, sorry to hear that some of the boys in the first portion of the alphabet are still unhappy about their situation.

I would be the first to admit that during the past year or so, we have had problems in that area, due to changing personnel handling it. However, in July of this year, the section was taken over by Win, W6RCD, who has since been working very hard to clear out the backlog and get caught up. My conversations with him in the past couple of months have indicated that he felt he had finally been able to get current, so it would seem that the situation should be alleviated by now.

I would suggest that you or your fact-finding committee send a list of the calls of the people involved direct to Win Goddard, W6RCD, 750 San Fernando, San Diego 6. I am sure that he will be glad to check his files against the list in an effort to determine just what the problem is. In this respect, I might add that I will also appreciate it if anyone in my section feels he has a problem, or wishes any information, that he get in touch with me directly. I have personally experienced a number of cases in which people complained bitterly about not having received cards for several months, when in fact, a check of my files revealed that they did not have an envelope on file, and there were large quantities of QSLs in the files for them, waiting to be claimed!

As a matter of information, Win is now handling only the calls beginning with "A" thru "K"; and I have the calls beginning with "L" thru "Z". I took over the additional letters "L" & "M" last January in an effort to lighten the load in the first section of the alphabet.

I would also appreciate it very much if you would send me a copy of your complete membership list, so that I could check it against my files to determine if any of your members have any unclaimed QSLs in the files. I have recently obtained a list of members of the SCDXC and the Orange County DX Association, and would like to include your members in my check. I intend to forward the results of my survey to the individual Clubs, in an effort to clear out some of the unclaimed cards. It might interest you to know that within the past year or two, the size of my files has increased by nearly 100%, due mainly to the large number of unclaimed QSLs on hand. I feel quite certain that there are a considerable number of these for members of the various DX Clubs.



I am suggesting this line of direct communication because mail sent to the Bureau Postoffice Box is of necessity delayed as much as four to five weeks in reaching the individual concerned, because of the fact that the Club meets only once each month, as does yours, I assume.

In corresponding directly with me, I would like to call your attention to my present address below. I notice that you are using my old Escondido address. Last year we completed a new home here in the Vista area, and moved in about 18 months ago. Incidentally, I find it to be a very good DX location, hi!

I am looking forward to attending the DX Meeting at Fresno again in January, and hope to have an opportunity to discuss these matters further with you at that time.

OCTOBER, 1966, MEETING

President Dave Baker, W6WX, called the October meeting to order at 9:22 p.m. at Dinah's Shack in Palo Alto. 43 were present, among them guests WB6RBH, WB6CCV, W6ESI and (not a ham) Walter LeCroix.

The reading of the minutes triggered a fine, good-natured session of "sniping" between Blue Team Leader, W6BHY, and our sterling -- er, uh, our self-confessed 14 karat gold-filled Red Team Leader, W6CUF. Both of these good-looking, powerhouse DX men flexed their kilowatts and exhorted their compatriots to battle in the Contest (am I forgiven, Jim?).... although all were enjoined to remember that the NCDXC should come first. Our first duty is to clobber the gents from Smogville.

Bob Thompson, K6SSJ, reported on developments for the program at the forthcoming Joint Convention at Fresno. He advised that W6MUR and W6KUT will debate the pros and cons of the propriety of \$'s-for-QSL's. This should enliven the program!

First readings were given to the applications of WB6CCV, W6ESI and WA6SII.

Second reading was given to WA6IVN's application. He was voted into full membership.

The subject of moving the Club frequency on two meters was raised, then withdrawn till after the fall contests are over.

Jim Neiger, W6BHY, pointed out that, as an ARRL Affiliate, the NCDXC has a distinct obligation to support the "Ham Quest" campaign of the ARRL. 100% of NCDXC members should belong to the ARRL.

There followed a lengthy discussion of problems with the W6 QSL Bureau, specifically citing the handling of cards for the first half of the alphabet. It was clearly pointed out that Otto Miller, K6ENX, who handles the second half of the alphabet, is doing an excellent job and is to be commended. A committee was appointed by the president to draft the contents of a letter on the subject, said letter then to be prepared and sent by the secretary. This protesting and constructive letter will be sent to the ARRL.

Herman Scholtens, W6OAQ, cited his problem with CQ Magazine regarding WAZ. In six months since submission, he has received neither certificate nor returned cards, nor has he received reply to any of six registered letters. He moved and W6SR seconded a motion to have the secretary write to CQ Magazine inquiring as to the delay and further inquiring as to normal processing time for WAZ recognition.

There were discussions on what constitutes associate membership and on CW practice for phone members who are interested in passing the Extra Class exam.

K6SSJ reported on his visit to two meetings of different segments of the SCDXC. He played interesting tapes of portions, including comments from SCDXC members to the NCDXC. Surprisingly, nothing required censoring. Wait till after the contest, though. There may be some smoke.

After a brief roundtable, the meeting was adjourned at 11:40 p.m..

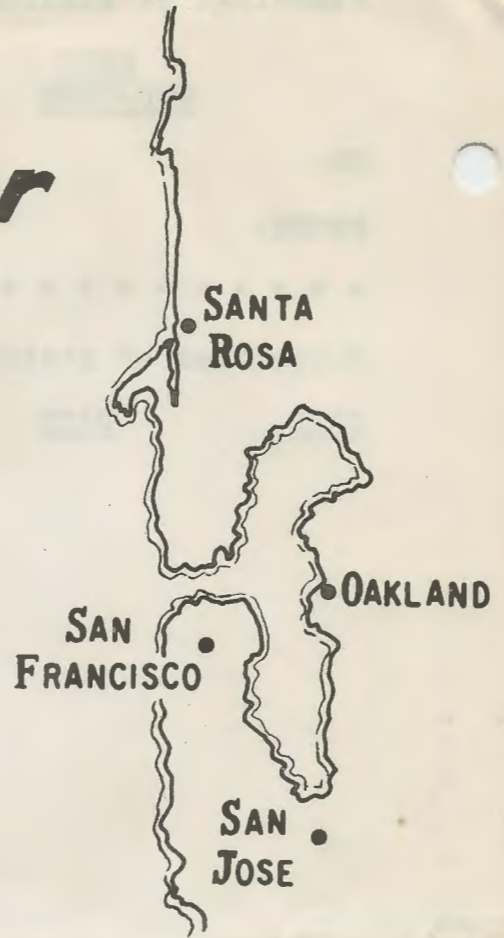
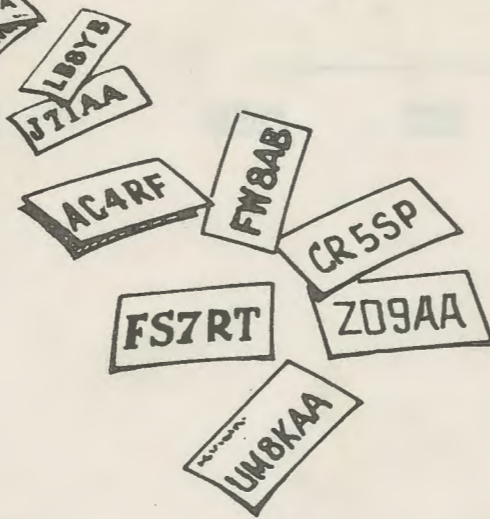
