MINUTES OF THE NOVEMBER 1986 MEETING OF THE NCDXC

The meeting was held at Harry's Hofbrau, Palo Alto, on November 14, 1986. The meeting was called to order at 7:47 PM by president K6TMB, Lou Beaudet. Ted Algren, KA6W, introduced our guests including OH2NB, Armas Valste, former president of the Finnish amateur society, SRAL. Rubin Hughes, WA6AHF, explained the criteria for the "Worked 30 and 60 YASME Awards" and provided handouts listing eligible call-

signs for the awards. Lou, K6TMB, explained the 40 zones in 10 days intraclub contest which commences December 10. Lou also commended the membership for observing the smoking ban in the meeting place. Bill Fontes, W6TEX, presented the 40th anniversary coffee mugs to those present, of the 87 club members who qualified for the 40/10 mini-marathon. The response to this event was very gratifying. A round table among the members, first for those without slides followed by those with slides, revealed many interesting anecdotes and tall stories. Lou, K6TMB, thanked everyone who participated in the round table and for a job well done. Jim Knochenhauer, K6ITL, presented the treasurer's report. The current financial status of the club is on target and consistent with budget estimates. Hal Godfrey, N6AN, acting secretary, gave first readings for prospective members W6TMA and K3EST. Second readings were given to W6HXW and N6LTN, both of whom were unanimously voted into membership. W6CTL applied for reinstatement and was unanimously voted into membership. W6CF made a motion to waive the reinstatement fee for W6CTL on the basis he was a vintage, 1947 club member and should be welcomed back into the club without the fee. The motion included a proviso that this action is an isolated case and is not to be construed as setting a precedent. The motion was seconded, voted upon and approved by the membership. Adam, N6QR, made a motion to amend the board's decision to ban smoking during club meetings. The motion provided for separate sections in the meeting place to be set aside for smoking and nonsmoking. The motion was seconded, voted upon and overwhelmingly defeated by the membership present. Bob Thompson, K6SSJ, advised the Christmas party would be held at the Elk's Club, Palo Alto, on Sunday, December 21. The meeting was adjourned at 10:00 PM.

MINUTES OF NCDXC BOARD OF DIRECTORS NOVEMBER 19, 1986

Meeting held at home of W6VG, Ron Panton. Present were K6TMB, K6ITL, W6VG, N6AN, and visitors KE6OT, K6SSJ. Called to order at 7:29 PM by president K6TMB. K6SSJ, Bob Thompson, gave report on status of Xmas Party which will be held at the Palo Alto Elks Club. Discussion on DX awards with KE6OT, Allen Stewart, re costs of materials, calligraphy, etc. A letter from Rich Hudgins, WX6M, was given careful consideration in re club awards. It was decided to let stand the present format in view of cost of plaques. A

pro tem committee of Marv Juza, W6FGD; Ray Griese, K6FD; and Ted Algren, KA6W, suggested changes in our procedures manual. The procedures manual will be changed regarding the application of regular/life members. A photocopy of the member's license, or verification by a club officer will be required. The forms for both classes of membership will be numbered in the procedures manual. All other forms will likewise have a specific number. The board felt that the FCC rules covers the class of license and frequencies used, and does not require mentioning in our procedures manual. The confusion regarding NCDXC and NCDXF requires international enlightenment. Letters will be written to overseas DX clubs. Design of NCDXC club QSL card discussed, but no changes are planned presently. W6CF requested permission to increase the size of the DXer occasionally. Board is in hearty approval of the quality of the DXer, and commends Jim highly for the wonderful job. However, in view of the postage and printing costs, regretfully feel that two issues in the next eight months will have to suffice. The presentation and approval of honorary members will be changed in the procedures manual in order to allow the board to review any nominations before the club votes on the nominees. The 40 Year Award certificate design was presented by Hal Godfrey, N6AN. The certificate will be printed as soon as possible as we already have seven DX station applitants. Other contest suggestions discussed, but none approved. Suggestions will be welcome by the board. The main idea is to get NCDXC stations on the air to help the foreign stations attain the 40 year award. Treasurer's report by Knock, K6ITL. At this time of the year we are solvent as the dues have come in over the last four months. Discussion on voting procedures for voting on life membership applications will result in changes in the procedures manual 1-107. Meeting adjourned at 11:30 PM.

I think the rest of the NCDXC should hear about the emergency handled on W6TI/R on Saturday evening, October 25, 1986.

I had just sat down to take a 2 hour stint on the spotting net for the CQWW SSB contest. Bob Thompson, K6SSJ, was net controlling. KD5GW broke on the requency and was politely told that we were a DX spotting net but we would stand by for emergency traffic. GW said he had an emergency. He was with a group of Boy Scouts at the Wildcat Campground in the

Point Reyes National Seashore and that a couple of the scouts had fallen over a cliff. He had a hand-held radio with him and this was the only repeater he could hear. I can't think of a more difficult area to work from - Wildcat Camp is about 7 miles north of the town of Bolinas with the last 3 miles accessible only on foot. There are 1000-1400 ft. high hills to the north and east; the ocean is to the west.

I volunteered to take the information from GW, as I am in Marin County. We were able to get the information and relay it to the Marin County Sheriff's Office and got help to them.

I want to thank the people on frequency for standing by so the traffic could be handled. This was happening at a time when the bands were active and a lot of DX was being announced. Instead of grumbling and suggesting other repeaters, etc., everyone graciously stood by so the traffic could be handled expeditiously. Things like this make me feel good to be involved with the NCDXC!

JANUARY 1 START FOR DXCC GOLDEN ANNIVERSARY AWARD

The kickoff for the ARRL Golden Jubillee DXCC award will occur before you receive your next DXer. Full rules were given in QST for September 1986, page 60. But the rules are really simple: work 100 or more countries on the ARRL Countries List between 0000 UTC January 1, 1987 and 2359 UTC December 31, 1987. Any combination of bands (except for 10 MHz) and modes is acceptable. QSL cards are not required - the League will accept your word when you certify that you've worked the requisite number of countries. No endorsements will be given. Certificates will be dated but not numbered. Application must be made on an official form, available from League Hg. for an SASE. DXer editor W6CF has copies, yours for an SASE. Copies will also be available at club meetings. Who will be the first NCDXC member to make the grade?

REPORT ON THE JY7Z DXPEDITION

The JY7Z operation in October was a joint effort comprised of six W6s plus three of the top operators from the Royal Jordanian Amateur Radio Society: N6AA (JY8RR), N6TJ (JY8TJ), N6VI (JY8VI), W6MKB (JY8TD), N6ZZ (JY8XX), W6NV (JY8NV), JY4MB, JY4YJ, and JY3ZH. The operation was conducted at the RJARS (JY6ZZ) club station in Amman and was primarily to participate in the CQ WW Phone DX Contest, although all of the Californians operated with their individual JY8 callsigns before and after the contest. Much work was done on antennas while there and JY6ZZ now sports separate monobanders on 40 thru 10 on 3 towers, plus wires on 160 and 80. The location, at the Hussein Sports City, was very quiet and provided nice accommodations for a multi-multi effort. During the contest, approximately 8000 QSOs were made, resulting in a score of roughly 14.5 million points.

The highlight of the trip was a private audience with His Majesty JY1 at the Royal Palace, plus several most enjoyable get-togethers with His Highness JY2RZ. in 1983 two Dutch radio amateurs launched Morsum Magnificat, a journal dedicated to the subject of Morse telegraphy. An English language edition is now available and it is claimed that it will cater "for all Morse enthusiasts, amateur and professional, active or retired, having an interest in the traditions and practice of Morse operating, from its earliest concept to the present time." The first issue, which has just been released, contains 48 pages. It includes an 1854 report on Morse speeds; illustrations of a number of old keys; a story of the Australian telegraph "Before the Flying Doctor;" G4FAI's story of "Tom Edison -Telegrapher;" entertaining early recollections by G3SRK; "Reflections of Uncle Bas," a popular series from the Dutch edition, with humorous memories of life at sea as a "Marconist," plus comments on today's amateur scene; the High Speed Clubs; GOCGB's nerveshattering first time on the key; a CW monitor by PAODW, and news items. The cost for U.S. subscribers is \$10 in U.S. currency for a year's subscription (4 issues) to Rinus Hellemons, PAOBFN, Holleweg 187, NL-4623 XD Bergen op Zoom, The Netherlands. William (Bill) W. Schmall, Sr., WD6AFC



Although Bill reports that Sharon is their quality control expert, making sure that jobs are completed properly, he admits that her primary function at times is to make sure that he toes the line and stays on the iob rather than sneaking home to work on antennas! Jut she knows how much Bill enjoys the hobby and even pitches in to help on antenna projects. She really must be the "great gal" Bill says she is! They have two sons, Shawn and Will, which means they have plenty of hands to hold guy wires when needed.

Antennas include a KT34A at 95 feet with four 1/2 wave slopers below it. The slopers are switchable between 40 and 80 meters. A home brew 3 element beam for 40 meters is at 65 feet on a second tower. 2 and 6 meter beams will eventually be put up on a third tower.

YEOOOWWWLLLS HEARD ON THE CATS NET



Club members are requested to make the following addition to their copies of the NCDXC Procedures Manual:

Table of Contents

ADD: 1-108 Honorary Membership - page 6a ADD: new paragraph, 1-108 Honorary Member-

- ship
 a. Any member may nominate a person, endorsed by five (5) members, for honorary membership. A nomination for honorary membership shall be submitted, in writing, to the board of directors detailing the reasons for the nomination including unusual and significant DX accomplishments by the nominee.
- b. The board shall, at its next regular meeting, consider the nomination and vote whether the nominee is acceptable as a nominee for honorary membership.
- c. If the board vote is to accept the nominee, the president shall present the board's vote, including details for acceptance, to the membership at the next regular club meeting. A vote shall be taken to either sustain or overturn the vote of the board. A vote of 2/3 of a quorum present shall sustain the board's vote and the nominee shall be declared an honorary member.
- d. If the board disapproves the nominee, the secretary shall notify the nominee's sponsor the reasons for disapproval.
- e. Honorary members are not required to pay initiation fees nor annual dues.
 - f. Honorary members shall be mailed copies of

each issue of the club publication and a copy of the annual club roster.

1-102 Processing

Subparagraph a. After - upon receipt of an application, ADD: (Form 8-105a),

1-103 Voting into Membership

Subparagraph e. First sentence, DELETE: the word "and" between address - phone. After phone number ADD: and class of license, 1-107 Life Membership

Subparagraph g. CHANGE: g. to i. DELETE: (8-105)

Subparagraph g. CHANGE: h. to j.

ADD: new subparagraph g. The president will call for a voice or show-of-hands vote on admission of the applicant to life membership. If the vote is not unanimous, those voting opposed shall be required to rise and voice their objections to the applicant being considered. The matter will then be discussed. If members voting opposed do not state their objections, their vote will not be counted.

ADD: new subparagraph h. Following discussion, the president shall call for a second vote on the matter.
