WA5YAS goes to HI8-Dec 21/23rd...to HH9-Dec 23-27th..and to 6Y5 from Dec 27-30th. Plans lots of 40/80 work. ZM2BT often brings ZM4OL/A up to the 3800-3810kc spot..look for Z M2BT from 0700Z...the Campbell station around 0730Z. 3805kc good spot to watch for Caribbean....KP4AN often m.c.ing from 1000Z.

LEGAL ?? While the question has been rather thoroughly dissected in the past, there still crops up questions as to whether a DX operation is legal. In the matter of licensing, it is possible for a DX operation to be thoroughly illegal as far as the country itself is concerned but is at the same time a valid operation as far as DXCC credit is concerned. The recent TZ-Mali operation, for example, was the first licensed operation from that country. However, any previous unlicensed operations could very well still be accepted inasmuch that amateur licenses were not being issued .."in the normal manner".

That quote is from Rule 7 in the DX Century Club Rules. If there are no licenses being issued in the 'normal manner' and some intrepid soul gets into the country and operates from within the country, generally it will be accepted. Should it be a country where licenses are being issued and someone tries an illegal operation; this may possibly be disallowed...Rule 7 again providing for this.

Sometimes there are questions raised to discount operations because there was no proper license issued. Generally these do not get up much steam as long as the operation was within the boundaries of the country and there is satisfactory proof available to bolster the claim of operation. The general rule for any DXer must be to work them first and question them later.....absolutely.
