CLIPPERTON The callsign for the coming Clipperton operation is not yet nailed down and some of the delay may be due to the group requesting a special call. Often referred to as 'FOSC', the group is asking for just that.....FOSC. The call should be in hand shortly and the long wait of the Deserving DXers for a Clipperton contact will be nearing an end.

Just about a month from now the first of the Clipperton group will be arriving in California. The second section will follow a few days later, the initial group due here about the 7th or 8th of March, the balance due on March 11th.

Departure from Southern California is tentatively set for March 14th and arrival at Clipperton on March 20th. This is right up in the Easter period. The operation is planned to run to March 27th. The group is expected back in California right after the first of April, probably about April 3rd.

Enroute, the operation will operate F5II/mm. The hangup on the Clipperton call may be due to the single letter suffix, it being understood that these are usually reserved for the military.

The present plans are to operate two separate stations, each located within its own tent. DENTRON has made an offer of tuners and linears to help with the effort. ATLAS has offered to supply their ATLAS 350s, even going to the extent of modifying the i.f. frequencies so that there will be no mutual local problems from operating in close proximity.

On their return to California, the current plans are for three of the Clipperton operators to stay over in California and attend the California International DX Convention at Visalia on April 15/16th. The schedule does allow time for the processing of the films taken by the Clipperton crew and a hot report will be given to the DXers in attendance. The Clipperton logs will also be available and some thought is being given to handling 'quickie' QSLs at the International DX meeting.

Charles Signer, WA9INK/6, who is handling the stateside affairs of the DXpedition, reports that contributions are starting to come in. The sea-going yacht which is capable of making the long-haul to Clipperton from Southern California will cost \$1500.00 a day to charter. Because of the size of the operating crew, the need for capacity to handle the gear and other logistic needs, a fair size vessel is needed.

Any financial support can be sent to Charles Signer, WA9INK, 2120 28th Street, Sacramento, California 95818. It is planned to respond to the ones supporting the effort with a special certificate. At this point there is a need to determine the extent of support as much of the planning will depend on the ability to fund them.

SUNSPOT LOUIE If last week was nothing that you deserved things should be better for the next couple of weeks

Remember that NhXX said that it would be 'Disturbed' on January 31st. Right on track was No. 988 which flared on that date, it pulling off the caper at 0139Z. This one did it twice on January 27th so you may understand that things were not exactly quiet. In fact there was indications of sub-flare conditions on the 28th and flares on the 29th. The Flux figures got up into the 140s the last couple of days in January, the geomagnetic Ap index jumping into the 40-50 area on the 30th and in the 25-35 sector on the 31st. All of which might indicate that a high flux figure may not in itself ensure High Normal conditions. It takes something else.

If you believe in Sunspots, and most DXers have a leaning that way, you might be interested in a two-part article in the January and February issues of ASTRONOMY. There are some spectacular photos of sunspots and a lot of other interesting information. Often you can locate this magazine in the larger libraries.

Back on the south bank of the Potomac, NhXX has worn out his snow shovel and is starting to break in a new one. But looking wistfully down the weeks of winter ahead to the time of the big Clipperton effort, Ted is unable to decide if he would rather see FO8C or a crocus blooming in the snow.

DX ADVISORY COMMITTEE

At the January Board of Directors meeting, the DX Advisory Committee made its second activities report for 1977. Because of the need to be informed, the entire report is reported here. Nothing has been changed or deleted.....you get everything!

The Second 1977 Semiannual Activities Report of the DX Advisory Committee

Gentlemen:

In pursuance of our advisory committee function the DXAC has considered the following since my last report.

1. Should Geyser Reef, Saudi-Arabia-Iraq Neutral Zone, and/or Spratly Islands be deleted under the provisions of Rule 4?

Geyser Reef is an unclaimed reef in the Madagascar Channel. The Spratly Islands are located in the South China Sea and are claimed by at least four countries, therefore they are allegedly unadministered since ownership is not clear. It should be pointed out, however, that areas involved in military conflicts have never before been considered for country status or changes therein. The Saudi Arabia-Iraq Neutral Zone is said to be unadministered by definition. In addition, Saudi Arabia and Iraq have signed, but as yet, have not ratified an agreement to divide the Neutral Zone between them.

On September 22, 1977 recommendation that Geyser Reef be made a deleted country under the provisions of Rule 4 was sent to the Communications Manager. No recommendation was made regarding the Saudi Arabia-Iraq Neutral Zone or the Spratly Islands due to the vote of the committee.

2. Does the Transkei meet country criteria by reason of 'distinctively separate administration"?

The Transkei is a new nation carved out of a portion of South Africa. Its request for admission to the United Nations was turned down unanimously with the United States abstaining.

You will remember than in March of this year the DXAC recommended not to grant country status to Transkei by reason of government. However, on September 22, 1977, the DXAC recommended that the Transkei be added to the DXCC List by reason of "distinctively separate administration".

3. Does the Autonomous Region in Southern Sudan (STØ) qualify for country status by reason of "distinctively separate administration"?

The 'Autonomus Region", according to Mr. W R Rindone, WB7ABK, came about during negotiations to end the Civil War in Sudan, when a bilateral agreement was reached which declared the three southern provinces of Equatoria, Bahr el Gazl and Upper Nile as having regional autonomy. Later, during final negotations a peace treaty, subsequently known as the Addis Accord, was introduced which granted end all troops in the 'Southern Command' are directly under the control of the 'Regional Peoples Assembly' which is the governing body of the 'Southern Sudan'. The Regional Peoples Assembly has its headquarters at Juba, the capitol of the Southern Region as established by the Addis Accord.

You will remember that in March of this year the DXAC recommended not to grant country status to the Southern Sudan by reason of government. However, on September 22, 1977 the DXAC recommended that the Southern Sudan be added to the DXCC list by reason of 'distinctively separate administration'.

4. Does Water Island meet country criteria by reason of 'distinctively separate administration'? Water Island, located in St. Thomas Hsrbor, is the fourth largest of the U.S. Virgin Islands and is administered by the Interior Department.

Recommendation that Water Island not be added to the DXCC List was sent to the Communications Manager on September 22, 1977.

5. Does the Pribilof Islands meet country criteria by reason of 'distinctively separate administration"?

The Pribilof Islands are located in the Bering Sea, north of the Aleutian chain, and are administered as a special reservation by the Interior Department.

Recommendation that the Pribilof Islands not be added to the DXCC List was sent to the Communications Manager on September 22, 1977.

6. Should a country be temporarily deleted for Honor Roll purposes if there has been no amateur radio activity there in the last 10 or 15 years?

This item would serve not to delete any countries but rather to expand the Honor Roll from the top ten listings, plus those countries which have been inactive for the past 10 or 15 years.

The DXAC is scheduled to vote on this matter in January, 1978.

7. Should any country on the DXCC List which bans amateur radio by not issuing amateur licenses to its citizens or by not allowing amateur operations by its citizens, be removed from the list for Honor Roll purposes until such time as the restrictions are lifted?

This item would serve not to delete any countries but rather to expand the Honor Roll from the top ten listings to the top ten listings plus those countries which ban amateur radio either by not issuing amateur licenses to its citizens or by not allowing amateur operations by its citizens.

The DXAC is scheduled to vote on this matter in April, 1978.

- 8. Should a new rule (Rule 5) be added to the Countries List Criteria which would state:
 - 5. Unusual Miscellaneous Areas
 - a) Any area which is classified as a Demilitarized Zone, Neutral Zone, or Buffer Zone will not be eligible for consideration as a separate entity.
 - b) Embassies, Consulates and extra-territorial monuments will not be eligible for consideration as a separate entity from the host country.

The DXAC is scheduled to vote on this matter in February 1978.

 Should the proposed Rule 5 as stated above be applied to the present DXCC list with those countries which meet its provisions be deleted February 1, 1978

10. Should the Spanish Sahara (EA9) be deleted from the current DXCC List?

According to the National Geographic, Morocco and Mauritania have ratified an agreement to divide this former Spanish colony between themselves.

The DXAC is scheduled to vote on this matter in January 1978.

11/12/13 Should valid contacts for all single-mode DXCC awards require that the applicant both transmit and receive in that mode with the confirming station? Should the cards indicate a two-way contact?

On September 22, 1977 the following recommendation was sent to the Communications Manager. Valid contacts for all single-mode DXCC awards should require that the applicant both transmit and receive in that mode with the confirming station. Although the DXAC feels it is desirable that all cards submitted for credit indicate a two-way contact, it is the opinion of the DXAC that so long as the card does not indicate that a cross-mode contact took place that it be accepted for credit. This rule should not be made retroactive.

The Communications Manager refused to consider this recommendation, alleging it to be a Board item as a result of Minute 23 of the July 1977 Board meeting which instructed the DXAC to consider the following:

Should QSLs for contacts made on or after January 1, 1978 for single mode DXCCs clearly show two-way contacts with each party using the same mode.

Therefore, recommendation to the Board, is that:

- A) Valid contacts for all single-mode DXCC awards should require that the applicant both transmit and receive in that mode with the confirming station.
- B) As long as the card does not indicate that a cross-mode contact took place, it be acceptable for credit for single mode DXCCs.
- C) This rule should not be applied retroactively and should be implemented only after due notice.

The committee realizes that it is a creation of the Board of Directors and that it was formed to advise the Board, or whomever the Board delegates. However, there has been some confusion between the committee and Headquarters staff as to who is to receive, decide upon, and/or implement the committee's recommendations. Many of these recommendations involve problems and situations thought too trivial to concern the Board as a whole, or for that matter, the Executive Committee. Until recently, the committee has been making its recommendations to the Communications Manager who is supposed to be the aegis of DXCC. This procedure has now been modified and the committee is directed to make its recommendations only to the Board.

Not only will this take too long for action to be taken in one direction or the other, but much of the Board's valuable time will be consumed while it considers such items. Therefore, it is requested that the Board lay down explicit guidelines allowing the committee to interface with the Headquarters staff as well as the Board of Directors, and which will direct and indicate to whom the committee's recommendations shall be presented and from whom action on such recommendations can be expected. As a result the committee will definitely be aware of the direction in which to point its recommendations and from where to expect action on these recommendations.

On still another subject, the Communications Department's staff is continuing to make every effort to see that the DXAC receives complete and timely copies of correspondence relative to DX interests. However, a recent embarassing experience indicated strongly to the committee that it has not been

receiving all the information available at headquarters. Information vitally essential to the committee's deliberations and recommendations. Hence it become obvious that provisions should be made to ascertain that such data continually be forwarded or furnished to the committee so that in the future unnecessary work would not be expended and unfeasible decisions would not be rendered.

In addition, it has been noted by the committee that some information relative to DX matters has, on occasion, been part of the material distributed through the Directors Letter. Therefore, it is recommended that the Directors Letter be circulated through the committee routinely. This would also serve to give all committee members the added insight so often necessary in making an intelligent decision and would still allow you to honor any committee member that you see fit with an Assistant Director appointment.

Finally, the questions and problems put to the DXAC are often very complex. It has been my experience as chairman that it is often necessary to utilize the telephone in order to resolve these questions and problems efficiently and intelligently and to maintain the overall viability of the committee. One on one contact between the chairman and the other committee members is easily accomplished, but nowhere do we have a means by which committee members can contact each other, save the weekly committee mailing.

This is slow and allows for only a very limited exchange of ideas. Therefore recommendation to the Board is that the annual budget of the DXAC be increased from its present \$200 to \$750. Now the chairman could allocate funds to each member of the DXAC and still maintain the \$200 necessary for overall committee use.

As always, I would like to thank the members of the DXAC, our liaisons, and the members of the Headquarters staff, who have helped the DXAC function successfully. And thanks to you, the Officers and Directors of the American Radio Relay League, Inc. without whose continued support there would be no DXAC

There it is, the DXAC Report in all its full word. It should be informative reading and in a week or so we will cover the report of the Contest Committee. For that group the report may not be verbatim but you probably will get most of it.

SOME SHORT NOTES Al Koblinski, W7XA, was the recipient of the Arizona DXer AWARD for 1977. The presentation was made at a meeting on January 11, 1978 of the Arizona DX Club. W7XA was hailed as an outstanding and active DX operator who has consistently demonstrated dedication to the principles of Amateur Radio.

W7IR, secretary of the Arizona DX Club, notes that any Arizona DXer holding DXCC or WAX.is eligible for the award and the winner is selected on the basis of a 12-point review.

Some problems are being encountered with QSLs for VE3EXT operations. The biggest problems is that they are being returned endorsed "Unclaimed" by the Canadian Post Office. George Collins has indicated that the postal service there was supposed to hold the cards for his return. As the problem has been reported in a number of instances, you might mark time until something definite develops. QSLs for VE3EXT's operations should eventually be accommodated but for the moment there are problems.

3Y6A was on from Bouvet a week or so back.....that's where he said he was anyhow. Initially around 14035kc on c.w., he later moved to 14105kc. Said he was a U.S. type, living in South Africa and did not hold a U.S. callsign. Said to QSL to the Norwegian QSL Bureau.

He further reported that his next stop will be FBSX-Kerguelen. This a good one? Maybe yes and maybe no. There are a few vibrating areas which you may take to indicate that this is (1) a true blue type, or (2) this is South Atlantic Slim. But never hesitate!! Work them first and worry later. That way you will never miss a good one. Perhaps a bit prematurely, we are always a bit skeptical about a rare one that suddenly shows and says to QSL via one of the bureaus. On the other hand we have seen some who give a QSL Manager who indignantly disavows any knowlege of the operation.

ARRL BOARD OF DIRECTORS MEETING on January 19th and 20th. You can read the full minutes in the March QST. It is well to read on January 19th and 20th. 1st i all the small print as you will gain a better idea of where the ARRL is headed.

One action which should bring the ARRL closer to the mainstream of legislative and administrative One action which should establish a position of Resident Washington, D.C. Representative. The President and General Manager were instructed to proceed immediately to establish the position and to seek from the amateur ranks a qualified candidate who must be approved by the Executive Board. A move to defer the position "...to study the establishing of such a position" was lost. Board. A move to by Director Max Arnold and seconded by Richard Ebbert. Thus sometime later this year you may have someone in Washington to represent the amateur radio interests.

Mention was made in the Contest Committee Report of the ongoing review of the DX competition which should be completed this year. The three-tier club competition plan recommended by the Contest Committee was ordered implemented.

The Headquarters Awards Committee may be in for some changes. Director Harry McConaghy put forth a motion that the membership on the committee be modified to include the Board Liaison members and the chairman of the Contest Advisory Committee and the DX Advisory Committee ... and the whole thing be renamed the ARRI Awards Gommittee. However, on metion of Director Larry Price, a substitute be renamed the Andrew Section of the Membership Affairs Committee to study the function and composition of the Headquarters Award Committee and to report its findings to the July meeting of the Board.

The scope of activity by the various advisory committees got some attention. Rule 7 of the Rules and Regulations Cencerning Advisory Committees was amended to read: "7. Advisory Committee authority shall be limited to the preparation of recommendations within its specialty area, based upon consultation with segments of the membership and upon Committee studies; there are to be presented to the staff and/or Board as appropriate to the situation. Advisory Committee recommendations may be solicited by Board motion or, during intervals between Board meetings, by the Executive Committee Technically, the Advisory Committees were initially set up to report only or the President" to the Board of Directors. In some instances the subjects are policy matters, in other they are administrative matters and the feeling has grown that a more flexible system would improve the handling of advisory committee matters.

Rule 4 of the Advisory Committee Rules was reworded so that members can be re-appointed for not more than one additional two-year term and will be again eligible for reappointment after the lapse of a year.

The VHF/UHF Advisory Committee and the VHF Repeater Committee were instructed to develop and present by Apri 1, 1978, recommended band plans for the 220 and 420mHz amateur bands, these plans to be used to encourage uniformity in the use and occupancy of these bands in ITU Region II.

The Board instructed the Executive Committee, as one of its continuing responsibilities, to review outstanding directives and recommendations which require follow up action by the staff, officers or committees. The Executive Committe shall report the results of their review.


On the single-mode DXCC Awards, the Board voted to table a motion which would have accepted the DXAC's recommendation for single mode DXCC contacts. The mileage limits in the WAS and 5BWAS was changed from twenty five to fifty miles. The Contest Committee was asked to review and report back in July their recommendations on the administration of ARRL activities, this to include the criteria for rejecting submitted logs.

A study was ordered of the possible licensing (no code) of microprocessor enthusiasts in the VHF/UHF bands. This will be studied by the Plans and Programs Committee. The Contest Committee was requested to undertake a study of the format and duration of the HF operating competitions.

A Public Relations Advisory Committee was suggested by Director John Sullivan and ended up being referred to the Plans and Programs Committee. A move to have the 'X' in 'XYL' be dropped from future publications of the ARRL failed to get a second and the idea never got off the floor.

That covers the major items from the Board meeting. There was a lot of other motions and you should read the whole and official minutes in the March QST.

A final comment might note that many items were referred to the study of various committees. Often it is difficult to determine what happens to these referrals inasmuch as the committee or Advisory Group reports back and the reports are not published. Actually, the practice in many instances is to submit the reports orally so that there is no written record for the minutes. However, read what is available and you will have a better idea of how things are going for you as an amateur and for the ARRL.
